 Four hours credit. Architectural drafting procedures, practices, terms and symbols including the preparation of detailed working drawings for residential structures with emphasis on light frame construction methods. The student will demonstrate a general understanding of architectural terms, symbols, use of residential construction materials and processes, and knowledge of reference materials. The student will demonstrate the ability to produce a set of residential construction drawings to include; site plan, floor plan, elevations, wall sections, schedules, details, and foundation plan. Two lecture and four lab hours each week. Prerequisite: DFTG 1409. Lab fee.
